Scoping a procurement process for LUO update underway towards release in early FY 25.
Connectivity, Bicycle, Pedestrian	Jones Ferry Road – resurfacing to add westbound buffered bike lanes. Center median work completed, NCDOT to resurface this summer.

	 South Greensboro Street Sidewalk – design underway, waterline replacement design nearing completion, coordination with NCDOT in progress to schedule street resurfacing in conjunction with project delivery. Signalized pedestrian crossings along NC 54 West – design completed. construction anticipated for the fall; NCDOT to manage construction. Bundle of Bike Plan Implementation Projects (Shelton St, Poplar Ave, Maple Ave), and Bolin Creek Phases 2, 3, and 4 were submitted for allocation of funds from the Regional Flexible Fund (RFF). The bike plan implementation and design for Bolin Creek Phase 2 are included in the projects under consideration for funding.
