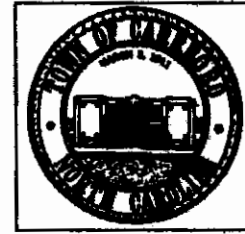

**Neighborhood Information Meeting
501 South Greensboro Street
9/26/2012**

The meeting began with an introduction by Runyon describing our project. He explained some of the history of the stormwater problem that affects our site, potential solutions, costs, and the importance of DOT participation. He also explained the implications of the cost of fixing the drainage problems – the only way to recoup our costs is through commercial retail. Runyon described the mill-like feel of the architecture, our green initiatives, the bicycle path, and asked for neighborhood input.

Residents asked many good questions about drainage and the like along the way as a picture of the project was formed. Residents asked about having local businesses leasing the spaces and had many suggestions about what they would like to see. Residents were concerned about traffic implications, specifically the connectivity to Purple Leaf Place. Residents had concerns about noise, light spill and the placement of dumpsters. We assured residents that we want to be good neighbors and will take these concerns into consideration. Residents expressed disappointment that we were not able to convince the county and Carrboro to bring the library to our site.
