A Resolution Calling a Special Election or Affirming the Decision to Fill the Council Member Seat Vacant by the Election of Mayor Barbara Foushee by Appointment

PURPOSE: The purpose of this item is to allow the Town Council to discuss and decide to call a special election or go through the process of appointment to fill the vacancy on the Town Council that was created upon Mayor Foushee assuming the office of Mayor.

INFORMATION: Mayor Barbara Foushee was elected as Mayor while still serving as Council Member for the Town of Carrboro. At the time of the Mayor's swearing-in, the seat on the Town Council became vacant with an unexpired term of December 2025. Pursuant to Section 2-2 (f) of the Town Code, as authorized by the North Carolina General Assembly, the Town Council has the authority to fill that vacant seat by an appointment process or by calling a special election as authorized by the general Assembly in the 2013 session.

The Town Council has directed the Town Clerk to provide a resolution calling for a special election that will be held on March 5, 2024 in conjunction with the General Primary Election and a resolution affirming the decision to fill the vacancy by appointment. The Council will decide which method they will use to fill the vacancy. If the Town Council foregoes the special election on December 5th and does not fill the seat by appointment, the seat can remain vacant, or a special election can be called at a later date.

FISCAL IMPACT: A special election will require contracting with Orange County Board of Elections to organize and operate the election. Since there is already a Presidential Primary planned for the election date, the estimated cost associated with the Town of Carrboro is zero dollars if the decision is made on December 5, 2023. An appointment to the council will not incur any cost to the Town of Carrboro. If Council chooses to call a special election after December 5th, the Town will incur cost totally approximately \$40,000.

RECOMMENDATION: It is recommended that the Town Council adopt one of the attached resolutions for appointment or a special election.

A RESOLUTION CALLING A SPECIAL ELECTION TO FILL A VACANCY ON THE CARRBORO TOWN COUNCIL

WHEREAS, Barbara Foushee was elected as Mayor; and,

WHEREAS, Barbara Foushee's current term as Council Member does not expire until December 2025; and,

WHEREAS, the Council Member seat is now vacant; and,

WHEREAS, the Charter of the Town of Carrboro requires that whenever a seat on the Town Council (other than that of the Mayor) becomes vacant that the Town Council decide to fill that seat by appointment or by calling a special election; and,

WHEREAS, a special election shall be called by the Town Council by the adoption of a resolution pursuant to G.S. 163-287.

NOW, THEREFORE, BE IT RESOLVED BY THE CARRBORO TOWN COUNCIL THAT:

- 1. A special election is hereby called for March 5, 2024 to coincide with the Presidential Primary Election date.
- 2. The filing Fee shall be: \$10.00.
- 3. The filing period shall be: Beginning at noon on Wednesday, December 6, 2023 and ending at noon on Friday, December 15, 2023.
- 4. The Town Clerk is hereby authorized to work with the Orange County Board of Elections to ensure the success of the special election.
- 5. March 5, except if the primary for county offices is not on March 5, then the special election shall be on the day of the primary for county offices.
- 6. The March 5, 2024 Town Council meeting is hereby cancelled if the special election is on this day.
- 7. This resolution shall be effective immediately upon adoption.

A RESOLUTION AFFIRMING THE DECISION OF THE COUNCIL TO FILL THE VACANCY ON THE CARROBO TOWN COUNCIL BY APPOINTMENT

WHEREAS, Barbara Foushee was elected as Mayor; and,

WHEREAS, Barbara Foushee's current term as Council Member does not expire until December 2025; and,

WHEREAS, the Council Member seat is now vacant; and,

WHEREAS, the Charter of the Town of Carrboro requires that whenever a seat on the Town Council (other than that of the Mayor) becomes vacant that the Town Council decide to fill that seat by appointment or by calling a special election; and,

WHEREAS, the Town Council has decided as a body to fill the vacancy by appointment,

NOW, THEREFORE, BE IT RESOLVED BY THE CARRBORO TOWN COUNCIL THAT:

- 1. The council will determine the method of appointment.
- 2. Carryout the appointment process at a future council meeting.
