Candidate Summary: Mr. Eldred submitted his application for the Planning Board in April, 2013. He has since reaffirmed his interest in serving by attending the May, 2013 Joint Review meeting and by meeting with the Chair of the Planning Board to discuss the responsibilities and commitments of advisory board service. Mr. Eldred is an attorney and has been working in private practice in Carrboro for 2½ years. His practice includes a focus on construction law and residential real estate law, among other areas. Mr. Eldred is active in the community as a volunteer coach with the YMCA and Chapel Hill Parks and Recreation. In the past he served on the Board of the Mental Health association in Orange County, including several officer positions. He states this experience has provided insight into workings of boards, and that his legal education and experience would also aid in his service on the board. Mr. Eldred wishes to be appointed to the planning board as he and his family intend to stay in Carrboro and he would like to have some input into how his town grows. Candidate's Name: Dana Davis Date of Application: 8/30/2012

Candidate Summary: Mr. Davis was appointed to the Planning Board in Fall, 2011, but was unable to serve due to work travel abroad. He was again considered for Planning Board membership in October, 2012 and February, 2013 but was not appointed. The Chair of the Planning Board spoke with Mr. Davis by phone on May 30, 2013, and he affirmed his continued interest in serving on the Planning Board and would like to attend the June Joint Review meeting to introduce himself to the current Board. On his application, Mr. Davis states he is committed to staying in the area and hopes to pursue a masters degree and a career in planning. Mr. Davis has worked on international urban planning and economic development projects in Kosovo, has several years experience in construction, and has served as a member of the Planning Board in Chelsea, MA.
