- 3) That the applicant bring the proposed color scheme for the building back to the Appearance Commission for a courtesy review.

This permit shall automatically expire within two years of the date of issuance if the use has not commenced or less than 10 percent (10%) of total cost of construction has been completed or there has been non-compliance with any other requirements of Section 15-62 of the Carrboro Land Use Ordinance.


