Motion was made by Clinton and seconded by Pendergrass that the Planning Board of the Town of Carrboro finds the proposed text amendment **is** consistent with the Downtown Carrboro Vision document and Carrboro Vision2020 as it supports, in a controlled manner, the growing interest in urban chickens, considered by many as part of Carrboro's quirky, artsy, historic mill-town character, and helps to maintain the high level of town services by the Police Department, and by association, Orange County Animal Services, who administers the provisions of the animal control ordinances.

Furthermore, the Planning Board of the Town of Carrboro finds the proposed text amendment, which will align the provisions of the Land Use Ordinance, with regard to setback provisions for certain livestock facilities, to those in the Town Code relating to Animal Control is in the public interest.
