PROPOSED UPDATES TO THE AFFORDABLE HOUSING SPECIAL REVENUE FUND

The purpose of this item was for the Board to consider the proposed changes to the Guidelines of the Affordable Housing Special Revenue Fund.

Nate Broman-Fulks, the Assistant to the Town Manager, provided the staff report to the Board.

Alderman Johnson noted that non-profits could apply for funding from the Human Services Funding and the Affordable Housing Fund and stated that the Board should determine if that is appropriate policy.

Alderman Chaney stated that a policy of how the funds are applied for, and by whom, would be helpful for the next budget year.

Robert Dowling, executive director of the Community Home Trust, thanked the Board for their assistance and asked that the Board consider the following changed to the Guidelines of the Affordable Housing Special Revenue Fund:

- 1.Include "of AMI" after the word "percentage" in 4E
- 2.Include the appraised value of a home in 9A
- 3.Consider how to include individuals that are purchasing an affordable home in Carrboro but are not yet residents in 7A
- 4. Consider specifying priority levels of AMI for 7F

Alderman Gist stated that she would like these funds to be available for use in building auxiliary units.

A RESOLUTION APPROVING THE UPDATES TO THE AFFORDABLE HOUSING SPECIAL REVENUE FUND

WHEREAS, the Board of Aldermen created an affordable housing special revenue fund on June 27, 2007 by the adoption of resolution no. 244/2006-07; and

WHEREAS, the Board of Aldermen established administrative procedures for the fund on September 9, 2008 by the adoption of resolution no 15/2008-09; and

WHEREAS, the Board of Aldermen has updated Land Use Ordinance provisions related to affordable housing in recent years; and

WHEREAS, updates to the fund guidelines have been prepared to coordinate with the Land Use Ordinance and Affordable Housing Goals and Strategies, to expand the ways in which the funds may be used and to clarify who is eligible to apply for funds and how they go about doing so.

NOW THEREFORE, BE IT RESOLVED that the Board of Aldermen hereby ordains:

Section 1. Previously adopted resolutions pertaining to creation and administration of the Affordable Housing Special Revenue fund are superseded by the actions in the following sections.

Section 2. The Town shall continue to maintain an Affordable Housing Special Revenue Fund. Payments to the Town made by developers in lieu of providing affordable housing under the applicable provisions of the Land Use Ordinance shall be deposited into this fund. Other revenue sources for the fund may include grants, donations, loans, interest payments, or other revenues that may become available.

Section 3. Disbursement authority, eligibility, application processes, loan limitations and other administrative procedures are specified in Exhibit A, "Guidelines for the Affordable Housing Special Revenue Fund"

Section 4. Staff shall amend the "Guidelines for the Affordable Housing Special Revenue Fund" as follows:

- 1.Include "of AMI" after the word "percentage" in 4E
- 2.Include the appraised value of a home in 9A
- 3.Consider how to include individuals that are purchasing an affordable home in Carrboro but are not yet residents in 7A
- 4. Consider specifying priority levels of AMI for 7F

REQUEST FOR MINOR MODIFICATION TO CONDITIONAL USE PERMIT FOR 300 E. MAIN RELATED TO WALL/SIDEWALK IN FRONT OF THE NEW FLEET FEET BUILDING/PHASE A

The purpose of this item was for the Board to consider adopting a resolution approving changes to the sidewalk area in front of the Fleet Feet building/Phase A of the 300 East Main project.

Marty Roupe, the Town's Zoning Administrator, made the staff presentation.

Kevin Benedict, representing 300 East Main, stated that it was a mistake and that he takes responsibility. The construction of the wall was directly related to slope issues. He stated that if the Board wishes for

them to remove the wall, they will but they are requesting to keep the wall.

Alderman Slade stated that he would be interested in hearing from staff if steps could be used without a wall. He also asked if the electrical boxes could be moved because they block the flow. Mr. Benedict stated that the electrical boxes can't be moved.

Alderman Chaney asked if the Board requested stairs and someone tripped and sued, who they would sue. Nick Herman, the Town's Attorney, stated that the Town shouldn't be responsible in that scenario. She suggested a wall with some steps that would provide a compromise.

Alderman Haven-O'Donnell asked if additional screening would be required between the existing wall and the established outside dining area and asked that additional screening be avoided.

Alderman Seils stated that his first priority is to have a 10ft wide sidewalk across the whole property, where constraints do not exist.

Alderman Johnson stated that she agrees that the sidewalk should be wider in that area and that she is would like to look into the stairs or moving the wall.

Alderman Gist stated that she thinks that the wall should be moved back to its originally planned location and that the sidewalk be increased.

MOTION WAS MADE BY ALDERMAN SLADE, SECONDED BY ALDERMAN SEILS FOR THE DEVELOPER TO PREPARE TWO PLANS; ONE WITH STEPS AND A WALL (MOVED BACK 5 FEET) AND ONE THAT DOES NOT HAVE A WALL AND INCLUDES 10FT SIDEWALKS. THIS ITEM SHOULD BE BROUGHT BACK TO THE BOARD DURING THE FIRST MEETING IN APRIL. VOTE: AFFIRMATIVE ALL

SIDEWALK CLEANUP/CLEARING DURING SNOW

Alderman Gist asked who's responsibility it is to clear the sidewalks in front of businesses and apartment complexes after snow.

Alderman Seils stated that currently, stores are required to remove the snow from sidewalks in front of their businesses.

Alderman Gist asked if this could be enforced because it is not being done in a lot of places.

The Town Manager and the attorney are reviewing the ordinance to see what changes can be made to enforce the ordinance.
