




FAMILY INCOME (US CENSUS AND ACS)












CENSUS 1990 AGE




CENSUS 2000 AGE




ACS 2010 (5-YEAR EST.) AGE




ACS 2016 (5-YEAR EST.) AGE







CENSUS 1990 RACE






ACS 2010 (5-YEAR EST.) RACE






Percent of Individuals 25 years and Older, Educational Attainment 1990 - 2016 (US Census and ACS)




Individuals 25 years and Older, Educational Attainment, 2000 - 2016 (US Census and ACS)






CENSUS 2000 EDUCATION



Housing Costs by Sales Data


Looking at 20 years of residential sales data, the total number of sales per year has decreased since the 1990s. The median sales price (adjusted to 2016 dollars) has increased by 87%, and the 25th percentile sales price, an indicator of where the lower end of the home price scale is, has increased by 111%. The gap between the median and the 25th percentile has increased by \$30,000 over that same time frame.

Square Footage Housing Costs by Sales Data, New Construction v. Existing Homes

Comparing new construction versus existing homes over the past 20 years, the average square footage of new homes has decreased by almost 500 square feet. However, the price per square foot (adjusted to 2016 dollars) has increased. In 1996, new homes were \$54/sf more expensive than existing homes. In 2016, this gap has shrunk to \$16/sf.



Housing Costs by Rental Data

DataWorks NC provides quarterly and annual cleaned and aggregated rental data by block group for four Research Triangle-area counties. Most listings in 2017 were for a one- or two-bedroom, and the median rent for all listings is \$1,178. Median rental prices are more affordable in the south and western part of Carrboro, and more expensive in the neighborhood near Carrboro Elementary and the part of town that includes the Webbwood, Spring Valley, Quarterpath Trace, and Bolin Forest neighborhoods.








CENSUS 2000 RESIDENCE
