

Thank you for providing a vehicle for neighborhood input to the development of 501 South Greensboro Street.

My main concern is walkability and access to biking in line with the overall culture of Carrboro and common understanding of the benefits to citizen health and safety. Anytime people can walk or bike we reduce traffic, pollution, costs to town and citizen alike, and promote health and community interaction.

I walk my 6 year old son to school from Old Pittsboro road to Frank Porter Graham on the far side of the highway. We have three other school aged children. There is no available crosswalk for us to use. This is from the city parking lot next to Open Eye Café, at the top of Greensboro all the way down the hill, past office buildings and a large trailer park, under the bridge, across entrance ramps to the highway, until the entrance to the school grounds on the far side.

We watch the fast traffic and sprint across when we see an opening. This is a tragedy waiting to happen. I asked town staff in the fall about how to ask the city to put in a crosswalk, and ultimately gave up after an hour long call with a state DOT official, who outlined all the problems and costs involved, where she suggested it was safer to cross without signage or walks in a high traffic area because then you watched out.

I did appreciate, however, the fact that city staff suggested this issue could be dealt with as part of the development in the works for the property in question.

My request is that <u>any development include well designated and signed crosswalks and pedestrian and bike –friendly attributes to allow easy crossing of Greensboro.</u>
