

EMERGENCY HOUSING ASSISTANCE


In FY 20-21 the Town provided \$290,000 in a combination of local & CARES funding to support rent, mortgage, and utility payments. The County allocated \$1.1M. Together, we provided pandemic related housing assistance to 452 Carrboro households.

The County administered the HOPE program when it was first released (October to February). During that time an additional \$584,600 was provided to 120 Carrboro households. The program administration is now being conducted by the State.

FOOD DISTRIBUTIONS

From July 1, 2020 to June 30, 2021 the Housing & Community Services
Department continued to respond to pandemic related community needs. With leadership from the Department of Social Services, eight food distributions took place at both Carrboro High School and Hank Anderson Park. A total of over 75 volunteers helped out.



RACE OF EHA & HOPE RECIPIENTS

Some households may have received both EHA and HOPE funds.


AREA MEDIAN INCOME



FY20-21 AFFORDABLE HOUSING SPECIAL REVENUE FUND (AHSRF)

Goal #1: Affordable Homeownership

Increase number of homeownership units that are permanently affordable in Carrboro. 2024 goal is to have 85 affordable ownership homes.

By July 2021, there were 75 permanently affordable homeownership units.



NEW AFFORDABLE HOMEOWNERSHIP UNITS

Through the Affordable Housing Special Revenue Fund, with guidance from the Affordable Housing Advisory Commission, and approval from the Town Council, \$100,000 was allocated to 4 units being built on Cobb Street by Habitat for Humanity.

PRESERVATION OF AFFORDABLE UNITS

5 Naturally Occurring Affordable Homes (NOAH) were preserved through 3 grants totaling \$8,565 to Rebuilding Together of the Triangle, The Marion Cheek Jackson Center, and Hope Renovations.

FY20-21 AFFORDABLE HOUSING SPECIAL REVENUE FUND (AHSRF)

Goal #2: Affordable Rentals

Increase number of rental units that are permanently affordable to individuals and families earning less than 60% of AMI.

2024 goal is to have 470 affordable rental units.

By July 2021, there were 379 permanently affordable rental units.



NEW RENTAL UNITS

Added 7 units to the permanent affordable rental housing stock through a \$40,500 allocation to Alliance of AIDS Services - Carolina.



PRESERVATION OF RENTAL UNITS

Repaired 12 existing units in the permanent affordable rental housing stock - through two allocations totaling \$26.583 to EmPOWERment.



FY20-21 OUTSIDE AGENCIES PROCESS

THE OUTSIDE AGENCIES PROCESS

The Town provides grants to non-profits through a once yearly application process. The non-profit agencies submit applications and present at hearings to the joint Chapel Hill & Carrboro Human Services Commissions. Funding recommendations are made by the Commission to Council. FY20-21 saw the highest amount of requests to date, totaling over \$550,000, with \$274,00 being granted to 45 non-profits. Health, Housing, and Food Security comprised 62% of funding.




- The Human Services Program funds programs that improve education, livelihood security, and health outcomes for Carrboro residents.

Emergency Housing Assistance

The collaboration between Orange County and the Towns has allowed for a coordinated, comprehensive program that has successfully prevented evictions for over 500 Carrboro residents during the COVID-19 pandemic.

Housing Goals

HCS continued to advance the Town's affordable housing goals by supporting the creation and preservation of homeownership and rental units and is on track to meet the established 2024 targets.

Human Services

The Town was able to fund 50% of requests from non-profits in FY20-21; Carrboro residents continue to need additional support including childcare, mental health services, and food security.
