DISCUSSION OF DOWNTOWN PARKING ISSUES

The purpose of this item was for the Board of Aldermen to hold a discussion and provide direction to staff regarding management of downtown public parking areas.

Annette Stone, the Town's Community and Economic Development Director, made the staff presentation.

Alderman Gist suggested that the Town host a public forum. She also suggested providing employees with hang-tags and allowing them to have extended parking in the garage. She also suggested using the inside bus advertising to let people know that the public lots in Carrboro are not park-and-ride lots. Annette Stone noted that the lease agreement limits the parking in the deck to two hours.

Alderman Slade suggested looking into more on-street parking options.

MOTION WAS MADE BY ALDERMAN HAVEN-O'DONNELL, SECONDED BY ALDERMAN SEILS FOR THE TOWN TO HOST A PARKING SUMMIT TO THE DISCUSSION OF PARKING AND SHARED PARKING. STAFF IS ALSO DIRECTED TO BEGIN A DIALOGUE WITH BUSINESSES IN NEED OF SHARED PARKING AND TO CONTACT THE BICYCLE COALITION AND UNC PLANNING. VOTE: AFFIRMATIVE ALL
