### DECLARATION ON THE INCLUSION OF CULTURE IN THE SUSTAINABLE DEVELOPMENT GOALS

Motion was made by Alderman Gist, and seconded by Alderman Seils, to approve the resolution below:

We, the undersigned organisations active in the field of culture and development:

#### Understanding the concept of development to comprise

a.human development: the pursuit of the full potential of citizens with physical, emotional, spiritual, intellectual, psychological and cultural dimensions

b.social development: the building and sustaining of structures, policies and strategies that facilitate and enhance the pursuit of human development, social cohesion and participatory governance

c.economic development: the creation of wealth and generation of economic resources that can help drive human and social development

#### Convinced of the unsustainability of

a.human development without fundamental rights and freedoms and respect for cultural diversity b.social development without social justice

c.economic development that exacerbates inequality and depletes natural resources

**Observing that** the cultural dimensions of development are too often ignored to the detriment of the achievement of sustainable development – human, social and economic

#### **Recognizing that**

a.culture – understood as an ensemble of values, traditions, tangible and intangible heritage, religious beliefs, worldviews and the expressions of culture in ways of living – can facilitate or impede the achievement of development goals

b.development – premised on values, worldviews, ideological beliefs, vision etc – is itself an act of culture that impacts, benevolently or adversely, on the culture of its intended beneficiaries

c.conflicts rooted in economic and power disparities may be fueled by the exploitation of cultural differences, with such conflicts impacting negatively on development through the destruction of infrastructure, social cohesion and human life and the flight of people with expertise

#### **Believing that**

a.strong cultural organizations and participation can play a key role in preventing conflict by promoting dialogue and a diversity of cultural expressions

b.development means participation in the cultural life of the community and access to the arts as fundamental human rights asserted in the Universal Declaration on Human Rights

c.as the fourth dimension of sustainable development, culture is as essential as the economic, social and environmental dimensions; and therefore, the safeguarding of heritage, diversity, creativity and the transmission of knowledge are integral to sustainable development

d.human development thrives on creativity, creative expression, the arts and cultural heritage as means of emotional and psychological catharsis, intellectual stimulation and the exploration, celebration and transformation of the human condition within given circumstances

e.social development requires creativity, a diversity of creative expressions, the arts and cultural heritage as means of education, social cohesion, intercultural dialogue and the building of national identity

f.economic development will benefit from capacity building and investment in all aspects of the value chain of the arts, creative industries, and tangible and intangible cultural heritage, by in turn creating jobs and generating income

**Recalling** the many United Nations resolutions, international declarations and instruments on culture and sustainable development, as well as the substantial evidence, gathered during the last two decades, of the positive role of culture in development.

# Convinced that culture is both a driver and enabler of development and should therefore be integral to Post-2015 Sustainable Development Goals based on

• A vision of the future anchored in human rights and universally accepted values and principles, including those embodied in the UN Charter, the Universal Declaration of Human Rights,

### Resolution Requesting Support for the Student Supporters of the 28<sup>th</sup> Amendment

WHEREAS, the Town of Carrboro was petitioned by a group of Wake County students known as the Student Supporters of the 28<sup>th</sup> Amendment (SSOTA); and,

WHEREAS, the SSOTA believes that the federal government has created a sense of distrust among the American citizens as evidenced by national polls and the belief that Congress can exempt themselves from the laws they pass, thereby abusing their power; and

Whereas, the SSOTA has proposed a 28<sup>th</sup> Amendment that would reassure the American people and put trust back in government; and

WHEREAS, this proposed 28<sup>th</sup> Amendment reads, "Congress shall make no law that applies to the citizens of the United States that does not apply equally to the Senators and/or Representatives; and Congress shall make no law that applies to the Senators and/or Representatives that does not apply equally to the citizens of the United States;" and

WHEREAS, the SSOTA has studied the mechanism for amending the United States Constitution, and is asking that the legislature of the State of North Carolina apply to Congress, under the provisions of Article V of the United States Constitution, to call a convention of the states to consider this proposed Amendment, and the SSOTA is asking local governments to support their efforts;

NOW, THEREFORE, BE IT RESOLVED BY THE CARRBORO BOARD OF ALDERMEN THAT:

The Town of Carrboro hereby supports the SSOTA efforts and applauds their work in civic engagement and involvement in government at the local, state, and national levels.

# ANNUAL REPORT ON SURFACE WATERS AND STORMWATER MANAGEMENT ACTIVITIES

The purpose of this agenda item was to provide the Board with an update on Town activities related to management of surface water and stormwater quality in the Town's jurisdiction. This includes requirements under the existing development provisions of the Jordan Lake rules and the Town's NPDES stormwater permit, and creek monitoring.

Alderman Gist asked for staff to continue to look at stormwater management in preparation of heavy rain events. She recommended that the Town pursue several methods of assisting homeowners to prepare for these events.

#### WORK SESSION ON NCNGN-AT&T MASTER NETWORK DEVELOPMENT AGREEMENT

The purpose of this item was for the Board of Aldermen to receive an overview of the North Carolina Next Generation (NCNGN) Master Network Development Agreement with AT&T for further discussion.

Andy Vogel, the Town's IT Director, made the staff presentation.

Elise Kohn, the Senior Advisor and NCNGN program director, spoke to the Board about the NCNGN program.

Walter Wells, representing AT&T, spoke to the company's participation in the NCNGN program.

Stan Waddell, Assistant Vice Chancellor for Infrastructure and Operations at UNC, discussed the University's role in the initiative.

Deron Bell, representing the Community Connections Program with CH-Carrboro City Schools,

discussed the NCNGN's role in reducing the digital divide.

Alderman Gist requested that the agreement be more inclusive of low income areas in Carrboro.

Alderman Seils asked if the speed can be improved to the FCC minimum level for broadband service. He asked about the exclusivity clauses in the agreement and stated that they concerned him. He pointed out that the agreement does not obligate AT&T to provide any of the services in the agreement but it does obligate the Town to provide certain services on AT&T's behalf. He stated that the nondiscriminatory language may limit the Town's ability to partner with future providers. He stated that he would like to see the term of five years be moved to seven years for the affordable housing areas. He asked that these points be considered in future NCNGN discussions.

Alderman Slade stated that he was concerned with AT&T being presented as the top choice without discussing the other respondents. He also asked if AT&T's privacy violations had been reviewed in the process.

WHEREAS, approval of a Google Network Hut Lease Agreement Form in advance of a potential Google

Fiber network build out would make construction as speedy and predictable as possible for Google; and,

WHEREAS, if Google selects a Network Hut site on Town of Carrboro-owned property then Google and the Town will follow the process established by N.C. Gen. Stat 160A-272 for leasing such site at that time.
