CONSIDERATION OF TOWN CODE AMENDMENTS RELATING TO BIKE LANES AND ON-STREET PARKING

The purpose of this agenda item was for the Board of Aldermen to consider three amendments to the Town Code relating to bike lanes and on-street parking.

Alderman Gist stated that she would like to have further public information available before this item is adopted. She stated that she would like feedback on how much it will disturb people parking in front of their homes.

Alderman Haven-O'Donnell stated that she thinks that most people follow the no-parking regulations however, during the last 25 years the neighborhood has transitioned and they may not know about the regulations and it is important to let newcomers know about the no-parking regulation before installing

signs. She stated that if folks are not parking on Pathway Drive, they are parking in the cul-de-sacs along Pathway Drive and this is problematic for access for emergency vehicles and should be addressed.

Mayor Lavelle asked if this could be brought back to a future meeting for a public hearing.

David Andrews, the Town Manager, stated that the item can be brought back for a public hearing on March 28, 2017.

Alderman Gist asked that the neighborhoods receive adequate notice of the public hearing.

Alderman Seils asked for the staff memo to be clear about where existing signage is already in place because it is his understanding that this amendment simply codifies where there are already signs. He asked that staff be clear on where there will be any changes on the ground from this amendment.

Alderman Slade asked for staff to include minutes from the Transportation Advisory Board when this issue was discussed.

Alderman Gist asked about for further information regarding the disposal of cat waste, dog waste, and diaper waste.
