IMPACTS OF SOUTH GREENSBORO ROAD CLOSURE

Terri Buckner stated that the traffic is bad on Jones Ferry due to the South Greensboro Street road closure and that the changes to the J route bus stop have created a hazard. She asked for staff to look into a solution for the bus stop. She also asked for the Board to focus on pedestrian safety.

Tina Moon stated that the South Greensboro Street road re-opening will be delayed due to weather.

David Andrews, the Town Manager, stated that he will provide an update to the Board and see about a temporary change for the bus stop.

Alderman Haven-O'Donnell stated that it would be good to contact neighborhoods to see the impact that they have experienced due to the road closure.

BOLIN CREEK

Bob Proctor stated that paving a bike path along the creek will damage the environment. He stated that the transportation planner should work to distribute estimated bike commuting routes before the path is paved.

AMENDMENT TO MARTIN LUTHER KING JR PARK DESIGN CONTRACT

The purpose of this item was for the Board of Aldermen to review and approve changes to the scope of the contract and funding for the park construction design project.

Alderman Chaney asked that staff hear from individuals that have design interest and have expressed a desire to contribute to the design.

AMENDMENT TO MARTIN LUTHER KING, JR. PARK DESIGN CAPITAL PROJECT ORDINANCE

Ordinance No. 18/2016-17

WHEREAS, the Board of Aldermen for the Town of Carrboro adopted Capital Project Ordinance No. 18/2014-15 authorizing the use of fund balance for certain designated capital projects; and,

WHEREAS, included in Capital Project Ordinance No.18/2014-15 was an appropriation of \$150,000 for the design of Martin Luther King, Jr. Park; and,

WHEREAS, the Town has contracted with Steward Engineering, Inc. for the design of the Park; and,

WHEREAS, the Town's annual audit at June 30, 2014 confirmed that the fund balance exceeds 35% and the amount above 35% may be committed for capital projects;

WHEREAS, the Town's desires to have the contractor perform additional work beyond the original scope of work

NOW THEREFORE, BE IT ORDAINED THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO:

Section 1: Funds in the amount of \$_33,200_____ are appropriated from fund balance in the General Fund for transfer to the Capital Project Fund for MLK Park Design which increases project funding from \$150,000 to \$_183,200____.

Section 2: The Town Manager is authorized to negotiate and execute an amendment with Steward Engineering, Inc. to modify the scope of work and increase the contract amount from \$_\$150,000__ to an amount not to exceed \$183,200 ____.

Section 3: Funds appropriated for this project are authorized to be undertaken until all project activity is completed.

Section 4. Within five (5) days after this ordinance is adopted, the Town Clerk shall file a copy of this ordinance with the Finance Director.

Section 5: This capital project ordinance amendment shall be effective upon adoption.

PRESENTATION OF TOWN MANAGER'S RECOMMENDED BUDGET FOR FISCAL YEAR 2017-18

The purpose of this agenda item was to receive the Town Manager's Recommended Budget for FY 2017-18 and set the time for a public hearing and budget work sessions.

David Andrews, the Town Manager, presented the recommended budget for FY 2017-18. He stated that he will provide the Board of Aldermen with detailed budget information on the Carrboro Day and Open Streets events.

Alderman Gist asked if funding for the Food Council has been included. David Andrews stated that it would be included in the FY 17/18 budget.

Alderman Chaney stated that she wants to be clear with what the Town gets from a salary study and how deep the study goes. David Andrews stated that Gallagher and Company have been hired to complete the study and they sample 30-40 positions with like-sized communities for benchmarking and the rest of the salaries can be adjusted based on the results.

Alderman Chaney asked if there was any flexibility to use the CDBG funds as something other than loan funds. She asked how the Town can best use the funds. David Andrews stated that the Town would have to go back to the federal government and receive approval to amend the program before changing the way the funds can be used.

Alderman Gist stated that the revolving loan fund was a grant at least 30 years ago and that there is interest money included. She asked if the funds are still tied to federal programming since it has been the Town's, with interest, for 30 years.

Alderman Seils asked if the body worn camera budget is reflected as carryover for next year's budget. Arche McAdoo, the Town's Finance Director, stated that the funds are shown on the capital budget rather than the Police Department budget.

In response to a question from Alderman Seils, David Andrews, stated that one of the assistants to the Town Manager will assume coordination of the implementation of the strategic climate and energy plan within the next fiscal year.

A motion was made by Alderman Seils, seconded by Alderman Haven-O'Donnell, that this resolution be approved.

LEAST INTEGRATED PEST MANAGEMENT POLICY UPDATE

The purpose of this agenda item was to present a draft update of the Town's existing Integrated Pest Management (IPM) Policy and to receive guidance from the Board of Alderman.

JD Freeman, the Town's Public Works Director, made the staff presentation.

Alderman Chaney suggested adding language to the policy that acknowledges dangers to public health and well-being is used as a determining factor.

Alderman Haven-O'Donnell asked that the community be educated with the intent of the program

because it is a model for use. She stated that working with the Environmental Advisory Board to get the message out would be beneficial.

The Board of Aldermen received the report and authorized staff to move forward with the manual updates.

RIGHT ON RED RESTRICTIONS

The purpose of this item was to discuss findings from an investigation to limit "Right on Red" at certain intersections within the Town.

JD Freeman introduced Eric Marsh, the assistant to the Public Works Director.

Erick Marsh provided the staff presentation. Town staff investigated the possibility of implementing a time limitation for traffic to make right on red turns at a stop light. Per this investigation it was discovered that there are currently not any major safety factors resulting from right on red at any intersections in Town. The Board did not adopt any changes to right on red intersections.

MATTERS BY BOARD MEMBERS

Alderman Chaney stated that Art Menius serves on the Orange County Transportation Advisory Board and suggested that the Orange County and Town of Carrboro Transportation Advisory Board meet together.
