Section 1: Amend the Town of Carrboro Advisory Board Recruitment and Appointment Policy by adding the following language to the "Recruitment and Appointment Process" section:

> o. As a presumptive policy, the Board of Aldermen will not appoint a person to serve on multiple advisory boards or commissions at the same time. However, the Board retains the discretion to make exceptions to this policy.

Section 2: Amend the Advisory Board Application to reflect this language

Section 3: This resolution is effective immediately upon adoption.

CONSIDERATION AND POSSIBLE APPROVAL OF A DEVELOPMENT AGREEMENT BETWEEN THE TOWN OF CARRBORO AND THE ARTSCENTER REGARDING THE 203 SOUTH GREENSBORO PROJECT

The purpose of this item was to provide the Board of Aldermen with an opportunity to consider and approve a Development Agreement between the Town and the ArtsCenter that will allow both parties to cooperatively proceed with the planning, design, and construction of the project, and possibly to incorporate space specifically designed for use by the ArtsCenter.

Alderman Gist stated that the Arts Committee will be paying their portion of the design and the building. She also clarified that the Town will not be responsible for their debt.

Alderman Seils asked about the condominium division of ownership and Bob Hornik clarified the ownership details and stated that it would be further clarified in the final agreement.

Alderman Chaney asked if there would be a first right of refusal and Bob Hornik stated that could be incorporated into a future and final agreement.

Alderman Chaney asked what type of space would be built for the ArtsCenter. Dan Mayer, the Executive Director of the Arts Center, stated that they are unsure of the type space they will need. He stated that the ArtsCenter does not intend on going into any debt to finance their partnership.

Alderman Haven-O'Donnell asked when there will be a discussion regarding the ArtsCenter and their potential use of Century Center space. David Andrews, the Town Manager, stated that it would occur early on in the discussions.

Mayor Lavelle noted how the partnership provided a money-saving aspect to the project for all parties.

She suggested that this be discussed as part of the retreat work plan.

Alderman Haven-O'Donnell suggested that the Town begin now with educating the public on the comprehensive planning process.

Alderman Seils reiterated the importance of incorporating fun as part of community engagement in the comprehensive planning process.

Alderman Foushee asked how deep the conversation will go with the public and if staff would present cost information. Trish McGuire stated that the level of detail will be higher level at first, but that some may be able to dive deeper into the information and gleam more.

Mayor Lavelle stated that the Town could be divided into "spaces" in a way that all neighborhoods could have involvement.

Alderman Gist suggested walking tours to let people know about the project.

Alderman Chaney asked that the Board make sure that everyone is clear on what a plan is in a way that helps staff lead the conversation.
