DRAFT INCLUSIVE CARRBORO COMMUNICATIONS AND COMMUNITY OUTREACH PLAN

The purpose of this agenda item was to provide a plan of action and strategies to increase access to information, resources and participation in civic processes by the entire Carrboro community with renewed focus on people of color, immigrant, refugee and other marginalized communities.

Council Member Haven-O'Donnell asked that Goal #5 be reconsidered based on lessons learned from the COVID-19 pandemic, especially the long-term nature of the COVID-19 pandemic.

Council Member Foushee stated that there were not enough people of color on the Communications Team and asked that there be more diversity on the team. She also referenced the Town Code update that is underway to remove gender-specific language from the Code and asked that the Code also be reviewed from a racial equity standpoint.

Catherine Lazorko, Communication Director for the Town of Carrboro, addressed the plan and explained how the Communications Team was developed.

MOTION WAS MADE BY COUNCIL MEMBER HAVEN-O'DONNELL, SECONDED BY COUNCIL MEMBER SEILS, TO ACCEPT THIS PLAN WITH THE RECOMMENDATION THAT GOAL #5 BE REVIEWED AND UPDATED AS NEEDED BASED ON LESSONS LEARNED FROM THE COVID-19 PANDEMIC. VOTE: AFFIRMATIVE ALL.

UPDATE FROM CHIEF SCHMIDT ON COVID-19

Carrboro Fire Chief, Dave Schmidt, provided an update on the response to the COVID-19 pandemic.

The Town Council asked Chief Schmidt to:

- work with the Orange County Multi-Agency Coordination (MAC) and Policy Group to clear up potential discrepancies that the accounting practices could cause.
- Work with Orange County so that that information about the Orange County COVID-19 hotline number be disseminated to residents of Carrboro..

The Council discussed issues related to representation at the MAC Group with a focus on ensuring representation of Carrboro's interests when the mayor is unable to attend.

FISCAL YEAR 2020 FINANCIAL UPDATE

The purpose of this item was to provide an update on FY20 revenues and expenditures to date.

Cary McNallan, Budget Analyst for the Town of Carrboro, provided the staff report on this agenda item.

The Council discussed budget issues with an emphasis on the impacts of the COVID-19 pandemic.

CARES ACT GRANT EXPENDITURE PLAN

The purpose of this agenda item was for the Town Council to approve a plan on how to spend the CARES Act grant funds.

Cary McNallan, Budget Analyst for the Town of Carrboro, provided the staff report on this agenda item.

MINORITY BUSINESS ROUNDTABLE REPORT

Council Member Gist discussed the concept of an incubator village that could be established on Town-owned property on Old Highway 86.

Council Member Seils requested that staff consider synergies between the Inclusive Carrboro Communications and Community Outreach Plan and the outreach efforts that were discussed by Jon Hartman-Brown. He also expressed support for the concept that was presented by Council Member Gist for the use of the property on Old Highway 86.

MURAL UPDATE – END RACISM NOW

The purpose of this item was for the Town Council to receive an update on the Town's pursuit of approval to allow an 'End Racism Now' street mural to be painted in the street right of way for Laurel Avenue adjacent to the Town Commons

Trish McGuire, Planning Director, provided the staff report on this agenda item.

Nick Herman, Town Attorney, addressed issues of potential liability that the Town could face if painting is done on streets.

Council Member Gist recommended that town-owned parking lots be considered as an alternative location for the mural due to the timelines involved in getting approval to do the mural on a street.

The Council discussed options for the location of the mural.
