## TITLE:

Community Climate Action Plan Implementation Update

**PURPOSE:** The purpose of this item is to update the Board on Community Climate Action Plan implementation efforts.

**INFORMATION:** In 2001, the Carrboro Board of Aldermen joined the Cities for Climate Protection Campaign and committed to develop and implement a local action plan to reduce greenhouse gas and air polluting emissions (see page 11 at <<u>http://www01.townofcarrboro.org/BoA/Minutes/2001/06\_26\_2001.pdf></u>). In 2009, after completing an inventory of local greenhouse gas emissions with Orange County and Chapel Hill, the Board passed a resolution committing the Town to take steps to reduce emissions of greenhouse gases in relation to the CO2 limit of 350 parts per million (ppm; see page 12 at <<u>http://www01.townofcarrboro.org/BoA/Minutes/2009/12\_08\_2009.pdf></u>). In doing so, and through work both before and after the resolution, the Town has joined a group of more than 1,000 municipalities around the world taking action. A town-specific inventory was completed in 2011 (<<u>http://www01.townofcarrboro.org/BoA/Agendas/2011/04\_19\_2011\_D1.pdf></u>), the annual tracking of greenhouse gas emissions of Town activities got underway in 2013, and a Strategic Energy and Climate Action Plan for Town functions and service provision was accepted in 2014 (<<u>https://carrboro.legistar.com/LegislationDetail.aspx?ID=1799514&GUID=4487305B-F63B-431C-ACC6-F3F6C0F0FAB7&Options=&Search>=</u>).

In the fall of 2014, Carrboro held a series of 3 forums <a href="http://www.townofcarrboro.org/934/Planning-Board-Fall-Forums">http://www.townofcarrboro.org/934/Planning-Board-Fall-Forums</a>> related to climate action planning. Shortly thereafter, a Task Force

<http://www.townofcarrboro.org/718/Energy-and-Climate-Task-Force> was created and began work drafting a Community Climate Action Plan (CCAP). Drafts of the plan were presented to the Board of Aldermen <http://www.townofcarrboro.org/248/Board-of-Aldermen> and Carrboro advisory boards <http://www.townofcarrboro.org/228/Advisory-Boards-Commissions> and a public hearing on the plan was held in 2016. The Board of Aldermen accepted the plan in January 2017 ( <<u>https://carrboro.legistar.com/LegislationDetail.aspx?ID=2942871&GUID=F9B55891-569E-49F0-A4CE-705C811601C3&Options=&Search></u>= and see page 1 at <<u>https://carrboro.legistar.com/View.ashx?M=M&ID=525877&GUID=00FE6A10-718B-4FE5-82D7-8FD5C44B5668%20></u>).
