TITLE:

Initiation of Process to Pursue FEMA Public Assistance Funds

PURPOSE: The purpose of this item is for the Board to direct the Manager and staff to participate in the process for FEMA Public Assistance funding resulting from impacts from Hurricane Florence.

INFORMATION: On October 22, FEMA declared Orange County as being eligible for Public Assistance associated with damages from Hurricane Florence. This particular FEMA program is intended to “provide funds to assist communities responding to and recovering from major disasters or emergencies declared by the President. The program provides emergency assistance to save lives and protect property, and assists with permanently restoring community infrastructure affected by a federally declared incident.” In initial staff discussions, these funds could potentially be used to address impacts to and options for the Public Works facility including: losses incurred; a highly eroding stream bank adjacent to the fleet’s fuel tanks; and the potential unique opportunity for funding support for facility relocation. Contextual concerns include repetitive loss and operational impacts from recurring flooding, insurability in the future, and the risk/liability associated with a major fuel spill/incident. There is also the potential to receive funds to replace an undersized culvert on Broad Street. A staff memo provides additional information.

At this stage it is preliminary to recommend or anticipate specific opportunities for these funds, and the level of support for the Town to seek. Staff are seeking Board approval to participate in a Recovery Scoping Meeting and potential submittal of information as an initial step in application for Public Assistance to get “in the queue” given the potential that these steps could need to occur before the Board begins meeting in January. If approved, staff will plan to provide more information to the Board after these initial steps.

FISCAL & STAFF IMPACT: There is no fiscal impact with the initial stage of exploration of Public Assistance funding. Staff time will be required to prepare for, participate in, and follow up on a Recovery Scoping Meeting possibly before the Board begins meeting again in January.

RECOMMENDATION: It is recommended that the Board of Aldermen direct staff to participate in the Recovery Scoping Meeting and follow up activities, and report back to the Board with recommendations.
