### TITLE:

Energy and Climate Protection Plan and Community Climate Action Plan Implementation Update

**INFORMATION:** The purpose of this agenda item is to provide the Board with an update on the implementation of two climate action plans, the municipal Energy and Climate Protection Plan (ECPP) and Community Climate Action Plan (CCAP). Work on the ECPP has been underway since the Board's adoption on May 28, 2014. (A complete copy of the ECPP can be found at:

This update includes a summary table (Attachment C) followed by a more detailed report describing ECPP and CCAP implementation since the May update (Attachment D). The report includes more recent information related to rate changes affecting the possible transition of Town streetlights to light-emitting diode (LED) lighting. The report also includes information about a new grant opportunity related to electric vehicle charging stations. Staff requests feedback on both topics.

**FISCAL & STAFF IMPACT:** There is no fiscal or staff impact related to this update.

**RECOMMENDATION:** Staff recommends the Board consider the two attached resolutions: 1) Receive the report and authorize staff to further pursue the transition of Town streetlights to LED lighting (Attachment A) and 2) Authorize staff to pursue a grant related to electric vehicle charging infrastructure (Attachment B).
