INFORMATION: On June 19, 2018, the Town Council awarded a contract to RKA for preliminary design services for a new section of sidewalk extending along the west side of South Greensboro Street from the north end of Old Pittsboro Road to Public Works Drive. During the review of the plans at the 65-percent design stage, the Town learned of a potential conflict with the proposed drop-inlets associated with the stormwater management system and an existing 6-inch OWASA waterline. An agenda item was provided to the Town Council on November 16, 2021, to discuss options, associated costs, and to request authorization to seek additional funding. After a series of discussions with OWASA, RKA and NCDOT, a path forward has been identified involving the replacement of the 6-inch line with a new ductal iron pipe (DIP). RKA is preparing a scope of work for the additional design work needed for the waterline replacement.

Staff had anticipated preparing a single agenda item to request the Council's authorization to extend RKA's

contract and to increase the contract amount to address the additional work; however, the scope of work and NCDOT's subsequent audit is not yet complete. Staff will bring back a follow-up item in the early fall to address the additional scope of work.

FISCAL & STAFF IMPACT: The amendment is necessary to extend the contract period to align with the current project timeline. No additional costs are associated with this extension request.

RECOMMENDATION: Staff recommends that the Town Council consider the resolution *(Attachment A)* authorizing the Town Manager to execute a contract extension with Ramey Kemp & Associates.
